COMMISSION COMMENTS:

Commissioner Erbacher reported that he would be participating in the Urban Shield 2014 exercise this year. Urban Shield has grown into a comprehensive, full-scale regional preparedness exercise assessing the overall Bay Area UASI Region's response capabilities related to multi-discipline planning, policies, procedures, organization, equipment and training. Urban Shield continues to test regional integrated systems for prevention, protection, response and recovery in our high-threat, high-density urban area.

The overarching goals of Urban Shield include striving for the capability to present a multi-layered training exercise to enhance the skills and abilities of regional first

responders, as well as those responsible for coordinating and managing large scale events.

Commissioner Shaw reported that San Francisco International Airport will be having an emergency services exercise on September 24, 2014 between 9:00 am and 2:00 PM.

Commissioner Chiechi located disaster preparedness information on the humane society web page concerning pets. He is going to try and obtain some pamphlets to hand out during the fog fest.

Commissioner Chiechi is continuing to work on contacting the local Boy Scout troops. He will be attending a meeting on August 27, 2014 with Troop 273.

Commissioner Salisbury met with Melissa Ambrose from Oceana High School and she was advised that there are three students interested in the positions that are currently completing resumes.

Commissioner Johnson is completing a poster board of pictures from recent earthquakes in the area for the Fog Fest booth.
