Subj: Marijuana Use Permit (MUP) Application Processing Order

On May 9, 2018, the City of Pacifica ("City") conducted the random independent ranking process ("Lottery") for Marijuana Use Permit ("MUP") applications which is described in Section 9-4.4804(a)(2)(iii) of the Pacifica Municipal Code ("PMC"). As explained in my memorandum from April 19, 2018, the PMC imposes various numerical limitations on MUP issuance which will affect the order in which the City processes MUP applications. The table in Attachment A below reflects the MUP applications which the City is able to process immediately in accordance with the PMC and which applications are on-hold until the disposition of other applications is known.
